**FIRST AMENDMENT TO VACATIONLAND SUBDIVISION ROAD MAINTENANCE
AND FEES ASSESSMENT DECLARATION**

THIS FIRST AMENDMENT TO DECLARATION made this 6 day of

July, 2005 by the VACATIONLAND HAWAII COMMUNITY

ASSOCIATION, INC., a Hawaii non-profit corporation, whose address is Rural Route 2,
Box 4008, Pahoa, Hawaii 96778 (hereinafter the "Declarant");

W I T N E S S E T H:

WHEREAS, the Declarant is an association of property owners including property owners who reside in and/or own properties located within the subdivision known as Vacationland Hawaii Unit I and Unit II ("Subdivision") in the District of Puna, County and State of Hawaii, which is comprised of lands more particularly shown on Subdivision File Plan Nos. 814 and 920 filed in the Bureau of Conveyances of the State of Hawaii (the "Bureau"), and property owners who reside in and/or own properties located outside of the Subdivision who have the right, easement, title or interest, or who by necessity are required to use the Subdivision's roads for access to a public highway; and

WHEREAS, the Vacationland Subdivision Road Maintenance And Fees Assessment Declaration (the "Declaration"), dated April 18, 2002, was filed in the Bureau on April 19, 2002 as Document No. 2002-068181; and

WHEREAS, Tax Map Key (3) 1-4-2-50 was inadvertently omitted from the Declaration as a property located outside of the Subdivision, the owner of which is by necessity required to use the Subdivision's roads for access to a public highway; and

WHEREAS, the Final Judgment filed in the Bureau of Conveyances of the State of Hawaii on October 30, 2000 provides in pertinent part that the :

1. Declarant is authorized and recognized as the entity responsible for collecting and administering annual and special assessments for the purposes of maintaining, improving and administering the roadway

- system of the Subdivision and any other roadway of which Declarant may in the future obtain ownership and become obligated to maintain;
2. The administrative costs allowed shall include, without limitation, the costs of meetings, notices and reasonable attorneys' fees and costs incurred in interpreting and litigating such issues concerning roadway assessment and maintenance as are authorized by Declarant or its authorized representatives;
 3. Except as otherwise provided in the Final Judgment (and this Declaration), all property owners within the Subdivision shall have a duty to contribute annual and special assessments for the purposes of maintaining, improving and administering the roadway maintenance program of the Subdivision as prescribed in Declarant's Bylaws;
 4. Said annual and special assessments shall be payable to Declarant or other legal entity as may be provided in Declarant's Articles of Incorporation and Bylaws, as they may be amended;
 5. Declarant shall be entitled to collection assessments as authorized in the Order from (1) the owners of real property abutting the Subdivision who use the Subdivision's roadways for ingress and egress to their properties; and (2) from the owners of real property located outside of the Subdivision who have the right, easement, title or interest, or who by necessity are required to use the Subdivision's roads for access to a public highway.
 6. The provisions of the Order shall run with the land and shall bind the parties their assigns and successors in interest.


NOW, THEREFORE, the Declarant hereby declares that the Vacationland Hawaii Community Association, Inc., a Hawaii non-profit corporation, (hereinafter the

"Corporation") shall collect and administer annual and special assessments for the purposes of maintaining, improving and administering the roadway system of the Subdivision used in common by the owners of properties described in Exhibit "A", attached hereto and by reference made a part hereof, pursuant to the provisions of the Bylaws of said Corporation, as amended from time to time.

This Declaration and the Bylaws, as the same may be amended from time to time, shall operate as covenants running with the land, and shall be binding upon all owners of lots described in Exhibit "A," and their respective heirs, personal representatives, successors and assigns. Said lot owners shall be bound by this Declaration in accordance with the Final Judgment and Order of the Circuit Court of the Third Circuit attached hereto as Exhibit "B", and by reference made a part hereof.
